Kinship Programs

The HALOS kinship care program provides direct services to families in which a grandparent, other relative, or someone close to a child steps in to raise them when a parent cannot do so safely. In 2007, HALOS began the first kinship care program in South Carolina, based on evidence of need and the lack of resources for this large and growing population of families. HALOS offers a range of opportunities for caregivers to gain support, meet critical needs, and connect with their peers and community.

The main component of the program is a service referred to as navigation, which is the label commonly used to define programs (cont. on Sch. O)

Research and Evaluation

HALOS, with the support of the SC Department of Social Services and The Duke Endowment, runs multi-year research and evaluation projects to build out the evidence base for kinship services. In partnership with Child Trends, efforts currently focus on kinship navigation models and the effectiveness of the Success Coach framework for kinship caregivers.

Kinship Care

The HALOS Kinship Care Program was the first, and continues to be the largest, provider of comprehensive services focused on the unique needs of kinship families. The main component of the program is a service referred to as Kinship Navigation. Navigation is the label commonly used to define programs that connect kinship caregivers to referrals and resources needed to promote the safety, permanency and well-being of children in their care. The HALOS Kinship Care Navigation Program has helped thousands of kinship caregivers in the tri-county region of South Carolina since it began in 2007. There are two other programs that have been created to specifically meet the unique needs of kinship families. Kindred Hearts, based in Richland County, provides support groups and referrals to kinship caregivers based in several South Carolina counties, with a focus on rural populations. Pendleton Place, a Greenville-based nonprofit organization that provides family assessments, youth resources and housing for teen girls, now offers kinship caregiver support groups and is in the beginning stages of offering a navigation service. In 2020, HALOS began collaborating and subcontracting with both organizations (supported by DSS grant) by providing funding, training and technical assistance in using our established model for Kinship Navigation, as well as guidance for offering caregiver support groups. In FY22-23, HALOS served 680 families, including 751 caregivers and 1,522 children.

HOLIDAY GIFT DRIVE

During the holiday season, many kinship caregivers can experience heightened stress as they struggle to provide for their family. Through the HALOS Holiday Giving Drive, HALOS partners with community organizations and individuals to bring the joy and happiness of the holiday season to children living in kinship care by providing them with holiday gifts. In FY22-23, 1,281 children received gifts through the HALOS Holiday Giving.

BACK TO SCHOOL DRIVE

August can be an especially trying month for kinship caregivers. As the school year begins, the HALOS Back-to-School Program partners with community organizations and individuals to collect and donate backpacks, school supplies, and uniforms to ensure that each child begins the school year ready to learn. In FY22-23 HALOS assisted 721 children at back to school.

SUMMER CAMP HALOS

raises funds to provide scholarships to camp or other summer activities that keep children safe and offer extracurricular opportunities when on break from school. Families apply to receive up to \$350 per child to assist with the cost of such summer activities. The majority of requests are for all-day summer camps that will keep children safe and engaged while the caregiver is working. Other activities that may be eligible include programs ranging from one week special interest camps such as tennis, art

or robotics, or a time-limited day camp. In FY22-23, HALOS sent 196 children in Charleston, Berkeley and Dorchester Counties to camp and other summer activities.

CRITICAL GOODS CAMPAIGN

Many children are taken in by kinship caregivers suddenly and unexpectedly. It is often an added financial burden if the caregiver does not anticipate having to purchase necessary and immediate items, such as a bed, a crib, or a car seat. HALOS provides these essential items needed for a child's health and safety, which can also ensure the caregiver is better equipped to keep a child out of foster care and/or keep siblings together. In FY22-23 Halos provided this financial assistance to 170 families.

FINANCIAL ASSISTANCE

Data shows kinship caregivers tend to be African American, live in poverty, be over 65 years of age, have poorer health and lower education attainment. HALOS with funding support from The Duke Endowment and other supporters provides direct assistance to 17 kinship families totaling \$54,032 in FY23 HALOS continues to be uniquely positioned to make a positive impact on kinship families in the Lowcountry navigating.
